**DESIGN EXCELLENCE HOME & OFFICE SYSTEM CO.**, a business entity duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office address at 1 Binmaka St., Cor. Biak na Bato, Brgy. Manresa, Quezon City, Metro Manila represented herein by its **PROJECT SALES CONSULTANT, JERICO FLORES**, hereinafter called the **SUPPLIER**.

**WHEREAS**, the Procuring Entity invited Bids for certain goods, **SUPPLY, DELIVERY, INSTALLATION OF FURNITURE AND FIXTURE** under **IB NO. 0005-20** for **Lot Nos. 1, 2, 4 and 5**, and has accepted the Bid offered by the Supplier for the supply of those goods and services in the sum of **One Million Eight Hundred Eighty-Eight Thousand One Hundred Pesos (PhP 1,888,100.00) inclusive of VAT** hereinafter referred to as the "**Contract Price**."

## **NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Bid Conditions and contents of this Contract.
2. The following documents shall be deemed to form and be read and construed as parts of this agreement, *viz.*:
  - (a) The Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract;
  - (f) the Performance Security; and
  - (g) the Entity's Notification of Award

3. In consideration of the payments to be made by the **Procuring Entity** to the **Supplier** as hereinafter mentioned, the supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the contract.
4. The **Procuring Entity hereby** covenants to pay the **Supplier** in consideration of the provision of the goods and services and the remedying of defects therein, the **Contract Price** or such other sum as may become payable under the provisions of the contract at the provisions of the contract at the time manner prescribed by said contract.


