C AND H COSMETICS INDUSTRY., a business entity duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office address at Brgy. Balat-Atis San Antonio Quezon represented herein by its **PRESIDENT, MR. HENRY V. RACA**, hereinafter called the **SUPPLIER**.

WHEREAS, the Procuring Entity invited Bids for certain goods, **SUPPLY, DELIVERY AND INSTALLATION OF VARIOUS MEDICAL, HEALTH AND SAFETY SUPPLIES** under **IB NO. 007-20** for **Lot Nos. 1, 2, 3 and 4** and has accepted the Bid offered by the Supplier for the supply of those goods and services in the sum of **Four Hundred Seventy Five Thousand Six Hundred Thirty Five and Thirty Centavos (Php 475,635.31) inclusive of VAT** hereinafter referred to as the **"Contract Price."**

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Bid Conditions and contents of this Contract.
2. In consideration of the payments to be made by the **Procuring Entity** to the **Supplier** as hereinafter mentioned, the supplier hereby covenants with the **Procuring Entity** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the contract.
3. The **Procuring Entity hereby** covenants to pay the **Supplier** in consideration of the provision of the goods and services and the remedying of defects therein, the **Contract Price** or such other sum as may become payable under the provisions of the contract at the provisions of the contract at the time manner prescribed by said contract.
