WHEREAS, the Procuring Entity invited Bids for certain goods, **SUPPLY, DELIVERY, AND INSTALLATION OF VARIOUS OFFICE EQUIPMENT** under **IB NO. 008-20** for **Lot No. 1** and has accepted the Bid offered by the Supplier for the supply of those goods and services in the sum of **One Million Six Hundred Thirty Five Thousand Five Hundred Pesos (Php 1,635,500.00) inclusive of VAT** hereinafter referred to as the "**Contract Price**."

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

In consideration of the payments to be made by the **Procuring Entity** to the **Supplier** as hereinafter mentioned, the supplier hereby covenants with the **Procuring Entity** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the contract.
3. The **Procuring Entity** hereby covenants to pay the **Supplier** in consideration of the provision of the goods and services and the remedying of defects therein, the **Contract Price** or such other sum as may become payable under the provisions of the contract at the provisions of the contract at the time manner prescribed by said contract.




